WEST SIDE NUT CLUB FESTIVAL PROPANE FUEL AGREEMENT - OCTOBER 4 - 9, 2021

\_\_\_\_\_ (Customer) wants Lin-Gas, Inc., to provide propane fuel in cylinders for use at the Festival. Lin-Gas, Inc. will provide propane cylinders to Customer's site, for its sole use during the Festival. Lin-Gas will make deliveries after we receive an order from your organization's representatives. **ORDERS MUST BE PLACED NO LATER THAN MIDNIGHT THE NIGHT BEFORE.** Order by contacting Lin-Gas at 812-424-9021 and after normal business hours use our website www.lingas.com to place your order. Cylinders will be delivered the next morning from 6 AM until 9 AM. Deliveries will not be made once the street has been closed to traffic, which is usually 9 AM.

Customer agrees to contact a contractor licensed and certified to install and service gas lines and equipment for cylinder installation and propane leak check. Contractor will provide safety certification of all propane equipment in or on your booth. Contractor will issue a certification document prescribed or supplied by Lin-Gas once testing is complete. Customer agrees to immediately send a copy of documentation to Lin-Gas. For questions, contact the West Side Nut Club at 812-464-2424.

Please do not allow anyone to work on, fill or tamper with Lin-Gas provided cylinder and equipment. Please do not allow anyone, other than a contractor licensed and certified to install and service gas lines and equipment, to service or repair any equipment that is in or on your booth. You must have any modified or repaired equipment recertified and a copy of such recertification sent to us.

Customer must comply with all laws and the instructions of any governing authority that may have jurisdiction over the Festival. This means that the fire department (and others) may inspect your installation and equipment to be certain it is safe and may tell you to do something. You must follow their instructions.

Review the safety information about propane entitled "If You Have a Propane Leak dated 090111" (page 2 of this agreement). Remember that propane is heavier than air, smells like rotten eggs and is extremely flammable. If you don't understand, ask us.

You agree to read and make certain that anyone else at your booth location is familiar with the characteristics and the hazards of propane and that they read all safety information. Go to our website www.lingas.com and open the tab marked Safety Tips and review the safety materials with your workers. You agree to indemnify Lin-Gas, Inc., for any loss, including reasonable attorney fees and costs, that is the result in whole or in any part due to your failure to train and review all safety material and warnings with people at your booth and to follow the warnings. If you have a problem, immediately turn off the valve on each tank (diagram on p. 2 of this Agreement) and contact us at 812-424-9021, 1-800-850-4380 or the fire department (911).

Lin-Gas, Inc. provides the propane, in cylinders, to Customer, together with an invoice and Customer agrees to pay Lin-Gas, Inc., for this service within 15 days from the delivery date. Customer will return ALL Lin-Gas cylinders and equipment at the end of the Festival. If you do not return all Lin-Gas cylinders and equipment at this time, you agree to pay the full, new replacement cost of such equipment. Please provide the following if we are to service your booth:

You will be charged the then current price for the size cylinders you use plus a hazardous materials fee at each delivery. We will bill you after each delivery and will want you to pay us 15 days from the delivery date. After 15 days your account will be past due and interest at 1 1/2% per month will be assessed until your account is paid in full. Our sales tax exemption continues to be in effect and has not been revoked.

If you agree to all of this, sign and date in the place provided below, mail; email to ebill@lingas.com or fax to 812-424-9056 and we will take care of the propane supply so you don't have to worry. Be certain to make a copy of this agreement (both pages) for your records or tell us and we will make a copy and mail it back to you. This agreement will remain in force and effect until modified by a subsequent Propane Fuel Agreement or you or we give the other notice to terminate it. The changes and terms shall survive termination of our agreement. This Agreement incorporates the terms, obligations and instructions of Lin-Gas' If You Have a Propane Leak dated 090111 found on page 2 of this Agreement and is hereby incorporated by reference.
