



IF YOU HAVE A PROPANE LEAK

1. Turn Shut Off Valve Clockwise (right) to stop the flow of propane
2. Evacuate people in the area of the leak or building
3. Ventilate the area or building
4. Call Lin-Gas, Inc., at 800-850-4380 OR 911 — fire department.
(DO NOT use phone in area of leak)
5. Stay outside until leak has been found and fixed.

IMPORTANT SAFETY INFORMATION FOR PROPANE USERS:

PROPANE IS A COLORLESS, FLAMMABLE GAS THAT PROVIDES MANY SUPERIOR BENEFITS OVER OTHER ENERGY FUELS.

TO HELP ENSURE THE SAFETY OF ALL PROPANE USERS, YOU SHOULD BE AWARE OF THE FOLLOWING:

1. A distinct odorant has been added to help detect a gas leak, which can cause accidents such as fire and explosion. Make sure you and your co-workers are familiar with this odor. If anyone on your premises cannot smell the odor of propane, call us immediately.
2. Propane is heavier than air and will collect at floor level. Carefully smell at floor level and in low spots to check for propane. Should anyone ever smell this odor, quickly open all doors and windows, vacate the structure and turn off the propane services valve at the tank. Do not switch electrical circuits on or off. Call Lin-Gas, Inc., or the fire department immediately from an off-premises telephone. Remain outside the area until the leak has been repaired.
3. Some people may not be able to smell the odorant in propane for various reasons, including medical limitations, odor fade, or masking by the presence of other strong odors. We suggest you install a propane gas detector in your structure.
4. Properly handled, propane is a safe, economical energy source. Do not permit anyone to service your propane appliances or controls or make a delivery to your business location that has not been properly trained. It is a misdemeanor for anyone except Lin-Gas, Inc., employees to fill or tamper with Lin-Gas, Inc., equipment.
5. Insure that you don't run out of gas. If a gas valve has been left open, a line disconnected or an appliance moved, a leak can occur when the system is repressurized with propane. Inform our trained personnel of any disconnected lines and ask that they relight all pilots in the event you were out-of-gas.
6. When there is incomplete combustion, carbon monoxide (and other gases) may form. Carbon monoxide is a toxic gas and is most often the result of poor combustion. Carbon monoxide is colorless, tasteless and odorless, giving no warning of its presence, so people breathing it do not realize they are being poisoned until symptoms begin to show. Some symptoms include severe headaches, dizziness, blurred vision, nausea, vomiting, confusion, disorientation, loss of muscle control, fatigue, sleepiness, rapid heartbeat or pulse, tightening of the chest, chest pain (angina) when exercising, fainting and loss of consciousness. It is recommended that you purchase and install a carbon monoxide detector.
7. Any hazardous material fee partially offsets costs incurred by Lin-Gas, Inc., to comply with Federal, State and local regulations imposed on suppliers of hazardous materials, including propane. It is neither a governmentally imposed fee nor is it necessarily proportionate to any transaction or group of transactions.
8. The distribution fee is a flat fee that offsets a portion of the cost to deliver the propane to your business and is not proportional to the transaction.
9. General Indemnity Provision. Customer shall indemnify and hold harmless Lin-Gas, Inc., its officers, agents and employees from and against any and all claims, damages, causes of action, suits and liabilities of every kind and character, including all expenses of litigation, court costs and actual, reasonable attorney's fees, for injury to or death of any person, or for damages to any property arising out of or in connection with the storage, use, handling, warning (or lack thereof), by Lin-Gas, Inc., under this agreement regardless of whether any such injuries, death, or damages, are caused by Lin-Gas, Inc., occurring or partial negligence, or the joint negligence of Lin-Gas, Inc., and Customer, or of Lin-Gas, Inc., and any other person or entities, or any combination of persons or entities. In the case of any doubt about the breadth of this indemnity in favor of Lin-Gas, Inc. Customer hereby agrees that it is to be interpreted in favor of Customer's indemnification of Lin-Gas, Inc., for it is the expressed intention of the parties to this contract, both Lin-Gas, Inc., and the Customer, that the indemnity provided by the Customer shall protect Lin-Gas, Inc., even from the consequences of Lin-Gas, Inc.'s, own concurring negligence, which may be one of the proximate concurring causes of the injury, death, or damage; the only exception to this indemnity obligation being where the negligence of Lin-Gas, Inc., is determined to be the sole proximate cause of the injury, death, or damage.
